Germany's Role and Responsibility in Global Health

The Agenda 2030 which contains the Sustainable Development Goals (SDGs), adopted by all United Nations Member States in September 2015, underlines the significance and importance of “Good Health and Well-Being” forming SDG 3 which is being linked with all other SDGs (e.g. no poverty, zero hunger, education, climate action, clean water and sanitation as well as peace, justice and strong organisations and partnerships for the goals), thus requiring a systematic implementation of “Health in All Policies”.

Especially as a consequence of the worldwide effective wake-up call caused by the two years lasting Ebola outbreak 2014/15, Global Health has been prominently positioned in the international agenda especially by the G7 in 2015 and the G20 in 2017 within the framework of Germany's corresponding presidencies.

Over the past few years, Germany has taken a strong leadership role making Global Health a strategic priority while significantly expanding its commitment in this area. Accordingly, a new Global Health strategy is currently being developed by the German Government under leadership of the Federal Ministry of Health and with the participation of non-state actors: five sectors –civil society, science, private sector think tanks, and youth – have been invited to contribute to this process by feeding in position papers. GHA has had the privilege to coordinate the position paper of the private sector.

Universal Health Coverage (UHC) and Health System Strengthening (HSS) have become key targets under SDG 3. Compliant to SDG 17, a multi-sectoral and interdisciplinary approach in line with the engagement and collaboration of national and international health actors is key when it comes to advancing Global Health issues.

This evening will focus on the exchange of perspectives and ideas on Global Health with German and international actors and decision-makers from politics, business, NGOs, and international organizations as well as science & academia.

At the occasion of this event, for the second time GHA will present the German Global Health Award launched in 2016 and further celebrate its formal merger of German Healthcare Partnership (GHP), German Healthcare Export Group (GHE) and German-Sino Healthcare Group (GSHCG).
